




Educational programme for midwives





Results of the tests

1. Czech Republic

Testing results

Evaluation of the contents

- Professional level
- Comprehensibility
- Clear structure
- Quality of the technical preparation

80% give the highest mark
20% had problems with understanding of some parts, and they would appreciate more figures and illustrations

Testing results

- User-friendliness
 - 40% give the highest mark
 - 60% had problems with initial orientation in the programme, they were not satisfied with a too long time period of link opening after clicking
 - It is not possible to extend the text in a larger window

Testing results

- E-learning preference in the future
- Personal benefit
- Recommendation to the others
- 50% will prefer e-learning also in the future
- The others would rather prefer personal contact, they would take e-learning as a complement to the contact instruction
